  - To cast a vote for a Board Seat, print the name in the space provided of your five (5) choices from the list of candidates shown on the Ballot Form. You can enter the same name in all five (5) board seats should the person not be elected in the first seat or following seats.
2. The ballot form must be notarized prior to being returned to the Election Committee Chairperson.
